AHAS KIRKHS ELECTION (2021)

In exercise of the powers conferred under the Constitution of the Islamic Revealed Knowledge and Human Sciences Students' Societies (IRKHSSS), the Executive Assembly makes the following regulations:

PART I

PRELIMINARY

Short title

1. This Regulations shall be known as the Election of IRKHSSS Regulations (2020)

Interpretation

2. In this Regulations, unless the context otherwise requires—

"Academic year" means an academic term during which an educational institution holds classes and assessment activities, consisting of two (2) regular semesters and one (1) optional short semester. A regular semesters run for seventeen (17) weeks while a short semester lasts for nine (9) weeks;

"Campus" means Campus of the University that has at least three centre of Studies;

"Constitution" means constitution of IRKHSSS;

"Centre of Studies" includes a Kulliyyah, Department, Institute or Centre of the University;

"Drawing lots" means the mechanism to determine who will win the election by selecting a piece of paper from the container where a piece of paper is marked and the candidate who picked the marked paper is the winner;

"External student" means a student registered at a Campus outside Malaysia or who is pursuing a short term, part-time, distance learning, exchange or allied programme, whether in or outside Malaysia;

"Examination" includes any manner or method of assessment which result in a mark or a grade for a specific course or part of the specific course;

"Kulliyyah constituency" means an election area which is restricted to the registered students of that Kulliyyah;

"International constituency" means an election area which is restricted to non-Malaysian registered student of the University;

"Polling station" means an area determined by the Election Commission for voting;

"Polling Station Officer" means officer in charge of administrative function during voting and counting process at the assigned polling station;

"Registered student" means a full time active student who is following a programme of study in the University, but shall not include an external student;

"Election Commission" means a committee that governs and determines any matters relating to the IRKHSSS Election;

"IRKHSSS Election Commissioner" means the Chairman of the IRKHSSS Election Working Committee and are empowered to give direction in regards to administration of the IRKHSSS Election Working Committee in respective Kulliyah of the University;

"Server" means hardware and software containing data pertaining to voting which are used during voting;

"IRKHSSS" means Islamic Revealed Knowledge and Human Sciences Students' Society of International Islamic University Malaysia;

"Voter" means a registered student of the University; and "Voting" means a voting process determined by the University.

"Executive Assembly" means the current Mainboard of Islamic Revealed Knowledge and Human Sciences Students' Society.

"AHAS KIRKHS" means AbdulHamid AbuSulayman Kulliyyah of Islamic Revealed Knowledge and Human Sciences. "KIRKHS" and "Kulliyyah" also carries the same meaning.

"Candidate" means the individual running for the respective constituency in the IRKHSSS General Election.

"Nominator" is the individual who nominates the candidate to run for election. "Proposer" carries the same meaning.

"Seconder" is the individual who makes a formal statement of support or suggestion for the selected candidate.

"Secretariat" is the student association that governs the development of the respective students in the department.

"Council of Chairpersons" means the council of secretariat presidents.

"Election" means IRKHSSS General Election.

PART II

DETERMINATION OF IRKHSSS ELECTION

Determination of IRKHSSS election

- **3.** (1) Without prejudice to other provisions relating to IRKHSSS election, the Election Commission shall
 - (a) conduct IRKHSSS election or to conduct re-election of IRKHSSS;
 - (b) to determine the date of IRKHSSS election;
 - *(c)* determine the election constituency; and determine the number of IRKHSSS representatives in election constituency.

(2) The IRKHSSS election shall be conducted in the first regular semester in every academic year.

(3) The members of the IRKHSSS shall hold the office for a period of not more than one academic year except if the member participate in the new election.

PART III

COMMISSION, COMMITTEE AND TRIBUNAL

Establishment of Commission, Committee and Tribunal

- **4.** For the purpose of IRKHSSS election, the following Commission, Committees and Tribunal are established at the respective Campus of the University:
 - (a) IRKHSSS Election Commission;
 - (b) IRKHSSS Election Working Committee;
 - (c) IRKHSSS Election Tribunal; and
 - (d) IRKHSSS Election Audit Committee.

Election constituency

- **5.** (1) For the purpose of IRKHSSS election, the Election Commission (EC) may determine the number of General seats and International seats as the constituency for the election.
 - (2) The Chairman of the Election Commission may, in certain circumstances, determine the control

of the election at the General and International constituency.

Election Commission

- **6.** (1) The Executive Assembly shall appoint any undergraduate student of AHAS KIRKHS, IIUM as Chairman of the Election Commission for the purpose of election at the Kulliyyah.
 - (2) The Election Commission shall consist of
 - (a) Chairman;
 - (b) Vice Chairman;
 - (c) Vice Chairman II;
 - (d) Secretaries;
 - (e) Treasurer
 - (f) Representatives of IRKHSSS Secretariats;

(3) The Executive Assembly may appoint other undergraduate students of AHAS KIRKHS to be members of the Commission.

(4) If the Chairman is unable to carry out his duties as Chairman of the IRKHSSS Election Commission on any grounds, the Executive Assembly may nominate any of the members of Election Commission to carry out the duties of the Chairman for the duration of which the Chairman is unable to carry out his duties.

(5) The minimum number of people needed to hold meetings for any Election Commission meeting is one third of its members.

(6) The Election Commission shall have the overall responsibility over the conduct of the election and shall have the powers to give orders and directives to ensure safe and proper conduct of the election which include the following:

(a) to determine the voting process of the election;

- (b) to determine the polling stations;
- (c) to take any action deemed suitable to ensure all the provisions in this Regulations and other directions or orders are observed;
- *(d)* to suggest on reasonable ground to the Chairman of the Election Commission to postpone, call off or annul the election; and
- (e) to carry out any other function or powers provided under this Regulations.
- (7) The Election Commission must be established 3 months prior to the Nomination period.

Election Working Committee

7. (1) The members of the Election Working Committee of the Kulliyah shall be appointed by the Chairman of the Election Commission.

(2) Two secretaries shall be appointed by the Chairman of the Election Commission from among the students of the AHAS KIRKHS.

(3) The Election Working Committee may propose to the Chairman of the Election Commission to form any other sub-committees that are deemed necessary for the election.

- (4) The Election Working Committee shall have the functions and powers as follows:
 - (a)to plan, administer, coordinate and monitor the election process and all matters related thereto;
 - (b)to issue any instruction pertaining to the running of the election and take any measures deemed fit for effective conduct throughout the whole process of the election;
 - (c) to assign work to other officers or staff of the University and Kulliyah, determine any documentation and equipment related to IRKHSSS election;
 - (d) to take appropriate action against any candidate, nominator or seconder of the candidate's nomination, as the case maybe, who contravenes this Regulations; and

(e) to be a referral centre pertaining to any matters as to the proper conduct of election.

Election Tribunal

- **8.** (1) The membership of the Election Tribunal shall consist of a Chairman and two officers of the IRKHS appointed by the Executive Assembly.
 - (2) Any member appointed under sub-regulation (1)
 - (a) must be a student of AHAS KIRKHS; and
 - (b) shall not be a member of the Commission or Committee under paragraphs 4(a)(b) and (d).

(3) A secretary shall be appointed by the Chairman from among officers of the University, provided that the secretary shall not be a member or secretary of the Commission or Committee under paragraphs 4(a), (b) and (d).

(4) The Election Tribunal shall have the jurisdiction all over the Kulliyyah and shall have functions and powers as follows:

- (a) to hear and decide appeal from any candidate, as the case maybe;
- (b) to invite any person or student to obtain any information and fact pertaining to the objection as to the conduct of the election; and

(c) to direct any Polling Station Officer to submit any documents pertaining to election to the Election Tribunal.

(5) The decision of the Election Tribunal is final and conclusive after the discussion with Chairman of Election Commission and Executive Assembly.

Election Audit Committee

9. (1) The Chairman and members of the IRKHSSS Election Audit Committee shall be appointed by the Executive Assembly from among the officers of the University other than members of the Commission, Committee or Tribunal under paragraphs 4(a), (b) and (c).

(2) The AHAS KIRKHS Election Audit Committee shall have the functions and powers as follows:

- (a) to confirm voters' data;
- (b) to confirm the data on aggregation of votes;
- (c) to require any person to confirm and certify the voting system; and
- *(d)* to examine the voting system at the polling station at least once before the voting commences.

(3) Any confirmation by the Election Audit Committee as to the data on the voters and aggregation of votes shall be final.

PART IV

NOTIFICATION OF ELECTION

Announcement of date of Election

10. The Chairman of the Election Commission shall announce the date of election and notify such date to the AHAS KIRKHS Election Working Committee.

Notice of Election Announcement

- **11.** (1) The notice on the announcement of the election shall be issued by the Chairman of the Election Commission or his representatives through notice or other means by which every student shall be able to take notice of the Election.
 - (2) The notice on the announcement of the election shall include
 - (a) date and time of nomination;
 - (b) date and time of voting; and

(c) any other matters relating to the election.

(3) The subsequent notice on the Election shall be issued by the Election Working Committee which shall include –

- (a) qualification to be a candidate;
- (b) number of constituencies;
- (c) number of representatives from each constituency;
- (d) period of nomination;
- (e) canvassing procedures;
- (f) polling date and polling stations; and
- (g) any other matter pertaining to the election.

PART V

NOMINATION OF CANDIDATE

Number of IRKHSSS Mainboard Committee

- **12.** For the purpose of the election, the Election Commission shall determine the number of mainboard committees of the IRKHSSS in the following manner:
 - (*a*) For the Presidential seats, chances of the seats are equal for local and international candidates 3 seats;
 - *(b)* for the Secretary seats, chances of the seats are equal for local and international candidates 2 seats
 - (c) for the Treasurer seats, chances of the seats are equal for local and international candidates 2 seats

Number of Council of Chairpersons Committee

- **13.** For the purpose of the election, the Election Commission shall determine the number of Council of Chairperson seats in in the following manner:
 - (a) Secretariat of Arabic Language and Literature-1 seat
 - (b) Secretariat of Communication 1 seat
 - (c) Secretariat of English Language and Literature-1 seat
 - (d) Secretariat of History and Civilization 1 seat
 - (e) Secretariat of Fiqh and Usul al-Fiqh 1 seat

- (f) Secretariat of Qur'an and Sunnah Studies 1 seat
- (g) Secretariat of Usul al-Din and Comparative Religion 1 seat
- (h) Secretariat of Political Science 1 seat
- (i) Secretariat of Psychology-1 seat
- (j) Secretariat of Sociology and Anthropology 1 seat

Qualification of candidate

14. (1) For the purpose of election, any registered student who is not disqualified from being elected under the Constitution, this Regulations, orders or directions, qualifies to be a candidate.

(2) The candidates who are contesting in the IRKHSSS Election must fulfill the following conditions-

- a) a registered undergraduate student of AHAS KIRKHS
- *b)* obtained CGPA not less than 2.80 for General seats and Council of Chairpersons seats whereas 3.00 for Presidential seat at the time of nomination;
- c) completed at least one regular semester for IRKHSSS seats.
- d) 1st year 1 semester students are eligible to be a candidate for secretariat seat.
- e) final year students are not allowed to contest in the election.
- *f*) have not been required to repeat one or more semester;
- *g)* have been not found guilty and convicted to any disciplinary offence under the Student Disciplinary Rules except for compoundable offences;
- *h*) students who hold positions in other societies/clubs or Mahallah may contest in IRKHS Election;
- *i*) not the member of Election Commission, Election Working Commission, Election Tribunal Committee and Election Audit Committee; and
- *j*) any other qualification determined by the Election Commission from time to time.

Disqualification of candidate

15. (1) Candidates shall be disqualified if only he/she does NOT fulfill the qualification criteria by the Election Commission or;

(2) Any conduct of candidate that contravenes the provision of any regulations determine by the Election Commission or;

(3) Upon the succession of disqualification, the result of disqualification shall be endorsed by the Tribunal and announced by the Election Commission to the Kulliyah.

Restriction on candidacy

- **16.** (1) Any candidate for the election shall participate for election on individual capacity and not representing any elements of student front in which the Election Commission deemed as unsuitable for the interest and well-being of the students of the University.
 - (2) A candidate shall stand for election for one constituency only.
 - (3) For all constituencies, the candidate must be a registered active student of the Kulliyah;
 - (4) A candidate shall not be a nominator or a seconder to the nomination of other candidate.
 - (5) A nominator or a seconder shall not be a nominator and seconder for other candidate.

Registration of candidate

17. (1) Any registered student who wishes to participate for the election should present necessary forms for the purpose of nomination at an online platform determined by the Election Working Committee.

(2)A registered student who wishes to apply for the nomination form shall produce his/her valid student card and latest examination slip.

(3) A reasonable payment may be charged for the nomination form.

Submission of candidate nomination form

- **18.** (1) The candidate for the all constituency shall, together with his proposer and seconder, be present to submit the certified nomination form and other related documents on the date, and at the time and medium determined by the Election Working Committee.
 - (2) The candidate shall submit the nomination form together with the receipt of payment of deposit.
 - (3) A nomination form submitted after the deadline of nomination period shall not be accepted.

(4) An incomplete or incorrectly completed nomination form is not valid.

(5)The Election Commission may call any candidate, proposer or seconder to obtain further information relating to the candidate's nomination form, if necessary.

(6) Proposer and seconder cannot be the same person.

(7)Where any candidate, proposer or seconder fails to appear before the Election Working Committee under sub-regulation (1) without any reasonable excuse, the nomination shall be rejected.

(8) This regulation does not apply for online mode of election.

Announcement of candidates who are eligible to stand for election

19. When all the certified nomination forms are submitted to the Election Working Committee, the list of candidates according to the contested election constituency shall be posted at the online media platform of the Kulliyah within the period specified by the Election Commission.

Objection to candidacy

- **20.** (1) Any registered student of the Kulliyah may object any nomination of a candidate to the Chairman of the Election Commission within the period as specified by the Election Commission by filling in a designated form provided by the Election Working Committee.
 - (2) Objection to any nomination may be made based on the following grounds:
 - (a) a candidate is not eligible to be elected as member;
 - *(b)* a candidate submits false information in the candidate's nomination form;the candidate's nomination form does not comply with any of the provision of these Regulations.

(3) The Chairman of the Election Commission or any officer of the Kulliyah authorized by the Election Commission shall exercise his function to decide on the validity of every objection submitted within a reasonable period on the nomination day and inform the candidate and the student who submitted the objection of such decision.

(4) The committee may invite any person to clarify and verify any issues related to the objection.

(5) The decision on such objection made by the Tribunal shall be final and conclusive.

(6) If the objection is found to be valid by the Election Commission, the nomination of the candidate shall be rejected.

Withdrawal of candidacy

21. (1) A candidate may withdraw from the election at any time by submitting his withdrawal letter to the Election Commission before the final list of candidates eligible to stand for election under Section 22 is announced.

(2) Any withdrawal from the candidate submitted to the election commission after the announcement of the final list of candidates eligible to run for election shall not be accepted.

- (3) Withdrawal of candidacy only can be made within the period of time from notice of election.
- (4) The deposit will not be returned back once the candidate withdraw from the election.

Final announcement of qualified candidates

22. The final list of candidates eligible to stand for election which has been verified by the Chairman of the Election Commission shall be displayed at the nomination centre of the Kulliyah.

Issues in candidate nomination

23. (1) In circumstances when there are no candidates nominated for a particular seat, the future position will be sworn into office through the endorsement of the Kulliyah.

(2) If a one-seat constituency is won uncontested, there will be an official statement by the Election Commission to endorse the position.

(3) Had a candidate won the election uncontested, the students are not required to vote for the constituency.

PART VI

ELECTION CAMPAIGN

Campaign

24. (1) The Election Commission and Election Working Committee shall be responsible for supervising and monitoring the running of the election campaign.

(2) A candidate, a nominator, seconder of a candidate's nomination and any registered student of the University may campaign in the manner and within the specified period, subject to the Memorandum and Articles of Association of the University, these Regulations and orders or directions issued by Election Commission.

Posters, banners, etc.

25. (1) No candidate, proposer or seconder of a candidate's nomination shall print, exhibit or distribute any posters, banners or use any electronic medium or other medium for campaign purposes without prior permission and approval by the Election Commission.

(2) Canvassing material (posters and banners) shall be submitted through IRKHSSS Election Comission official email for permission and approval.

Official Media

26. IIUMTODAY, IIUMFM and IIUMTV will be the official media of the election operating under the election commission.

PART VII

ELECTION

Polling day

27. (1) Voting shall be conducted on the date, time and at the online mechanism as specified by the Election Commission.

(2) The Election Working Committee may exhibit a notice containing voting guidelines at the Online Polling Centre prior to the election.

(3) All AHAS KIRKHS voters must be undergraduate students who have officially registered with the department.

(4) A voter shall fill in his full name, student matric number, departmental and email verifying his status as registered student at the university during the online voting process before he is allowed to vote.

(5) If any dispute arises during the polling day, the Polling Station Officer shall make a decision on the said dispute.

Polling day briefing

28. (1) A briefing will be made prior to polling day on the proper conduct of election by all stakeholders.

(2) The briefing will be made by the Election Commission Chairman, or anyone appointed by the Election Commission Chairman.

Polling Station Officer

29. (1) The Chairman of Election Commission shall appoint the Polling Station Officer who shall supervise the voting process on the system at the Kuliyyah.

Permission to enter Polling Stations

30. (1) No person shall be present at the Polling Station without prior permission from the Polling Station Officer.

(2) All candidates, proposers and seconders of candidate's nomination shall comply with all orders given by the respective Polling Station Officer.

(3) The Polling Station Officer shall ensure the peace and order at the Polling Station.

(4) If any person causes disturbance, nuisance, suspicion, or any other acts which in the opinion of the Polling Station Officer may interfere with the smooth running of the voting process, the Polling Station Officer or any officer at the Polling Station may direct the said person to leave the Polling Station immediately.

(5) The power conferred under Regulation 31 shall not be exercised to the extent of denying the right of a registered student to vote.

Prohibition on Polling Day

31. (1) No candidate, proposer, seconder of candidate's nomination or voter is allowed to -

- (a) carry out any form of campaign either written or oral during the polling day within the Kuliyyah buildings;
- (b) portray an identity which symbolizes the identity of any group;
- (c) behave unethically at the area of Polling Station;
- (d) disrupt the voting process in any other manner including:
 - i. attempt to gain and canvass for vote.
 - ii. distribute candidate's list name to the voters
 - iii. make noise or any form of nuisance in Polling Stations surrounding.
 - iv. disturbing or obstructing the Election Working Committee or officer of the Polling Station from doing his job; or
 - v. Distribution of cash handouts.
- (e) vote more than once; or
- (f) bring any document or prohibited items as determined by the Election Working Committee into the Polling Station except documents or items approved by the Election Working Committee.

(2) Only IIUM matric card or any necessary identification document is allowed to be brought in the polling station

(3) A candidate, proposer, seconder of candidate's nomination or any other voters may lodge a complaint regarding any matters under this regulation to the Polling Station Officer.

(4) The Polling Station Officer shall decide on the complaint received under sub regulation (2).

(5) Any candidate, proposer, seconder of candidate's nomination or any other voter who is dissatisfied with the decision of the Polling Station Officer under sub-regulation (3) may submit his appeal to the Election Commission.

Voting and aggregation of votes by online form

32. (1) The Election Working Committee shall provide adequate online polling form for voters.

(2) Prior to commencement of voting, the Polling Station Officer shall verify that the online polling form to be used is getting no response except when the voting period has started.

(3) If there is no candidate, proposer, seconder of candidate's nomination or any registered student of the Kulliyyah to fill in polling form during the voting period, the Polling Station Officer may proceed with the voting process until completed.

(4) The online polling forms are confidential and shall be kept in a secured system and can be accessed on the polling day only.

(5) The Election Commission shall determine the system and process of aggregation of votes.

(6) Any candidate, proposer or seconder of candidate's nomination may submit an objection in written form against the result of the aggregation of votes to the Office of Deputy Dean (Student Development and Community Engagement) or Chairman of Election Commission.

(7) Any objection may be made after the official announcement of the result of the aggregation of votes.

PART VIII

AGGREGATION OF VOTES

Centre for aggregation of votes

33. (1) Aggregation of votes shall be conducted at a place specified by the Election Commission.

(2) The Polling Station Officer shall ensure the online polling form is secure until the process of aggregation votes.

(3) No person shall be present at the center for aggregation of votes without prior permission of the Election Commission Tribunal officer.

(4) Notwithstanding sub regulation (3), the following persons are permitted to be present at the center for aggregation of votes:

(a) Polling Station Officer;

- *(b)* All members of the Commission, Committees and Tribunal appointed under Regulation 4;
- (c) Any officer or staff of the University appointed by the Election Working Committee; and
- (d) Candidate or proposer or seconder of candidate's nomination.
- (e) External observer allowed by Election Commission.

Head of Vote Aggregation

- **34.** (1) The Election Commission shall appoint a Head of Vote Aggregation from among Polling Station Officers.
- (2) The Head of Vote Aggregation shall -
 - (a) verify all the voting data before being audited;
 - (b)shall ensure necessary facilities to enable the smooth-running of the aggregation of votes.

Announcement of results of the aggregation of votes

- **35.** (1) Upon completion of the aggregation of votes, the Chairman of the Election Commission or his representative shall, as soon as possible, announce the results of the votes.
 - (2) For the matters pertaining to the recounting of votes; if-
 - (a) the number of votes between the candidates in an election constituency is equal, a recount shall be conducted; or
 - (b) there is a difference of one percent or less in the number of votes obtained between a successful candidate whose number of votes is the least among the other successful candidates, and the unsuccessful candidate who has obtained the highest number of votes from among the unsuccessful candidates, the Head of Polling Station Officer shall, upon the request by the said unsuccessful candidate, direct the recount of votes.

Illustration

5 students run for IRKHSSS Presidential Constituency. They are A, B, C, D, E. Candidates A, B, and C successfully won the election whereas candidates D and E were unsuccessful, but the difference of votes between candidates C and D is 0.89%. D may submit his application to recount votes.

5 students run for IRKHSSS Presidential Constituency. They are A, B, C, D, E. Candidates A, B, and C successfully won the election whereas candidates D and E were unsuccessful, but the difference of votes between candidates D and E is 0.89%. E may not submit his application to recount votes.

(3) If the result of the recount of the votes under paragraph 35(2)(a) is equal, a winner shall be decided by drawing lots in the presence of the Chairman of Election Commission and candidates according to the methods determined by the Election Commission.

- (4) For the matters pertaining to the recounting of votes; if-
 - (a) the results of recounting of votes under paragraph 35(2)(a) differs and the difference is one percent or less; or
 - (b) the results of recounting of votes under paragraph 35(2)(b) differ and the difference is one percent or less, upon the request of the candidate who obtained the highest number of votes in the original aggregation of votes, there shall be a recounting of votes.

(5) The result of recounting of votes under sub-regulation 35(4) shall be final.

(6) The Head of Polling Station Officer may defer the recounting of votes under sub-regulations 35(2) and 35(4), provided such deferment of recounting shall not affect the whole AHAS KIRKHS election process subject upon the approval of the Chairman of Election Commission.

(7) Upon the completion of the recounting of votes, the Chairman of the Election Commission shall as soon as possible, announce the results.

Objection and Appeal of the Election Result

- **36.** (1) Any candidate who is not satisfied with the result of votes under Regulation 33 may make an objection in writing by stating the reason of the objection to the Election Commission within a 48 hours period as specified in the election notice under Regulation 11.
 - (2) A reasonable payment may be charged for the objection of the result.

(3) The Election Tribunal shall decide on the objection and inform the objector, the person against whom objection is made, on such decision.

(4) If the objection is accepted by the Election Tribunal, the objected candidate shall be null and void.

(5) Subject to (4) the Election Commission has the right to re-conduct or re-election

PART IX

DECLARATION OF AHAS KIRKHS ELECTION RESULT AND APPOINTMENT OF IRKHSSS OFFICE CARETAKER

Declaration

37. The Chairman of the AHAS KIRKHS Election Commission or any Members of the Election Commission authorized by the Chairman shall declare and display the result of the election by any means which is deemed reasonable within one day.

IRKHSSS office bearers

38. The elected candidates shall form the IRKHSSS office bearers from among its members as follows;

- (a) President;
- (b) Vice-President 1;
- (c) Vice-President 2;
- (d) Secretary General;
- (e) Secretary II;
- (f) Honorary Treasurer;
- (g) Treasurer II; and
- (h) Another 10 Secretariats Chairpersons

Extension period of the IRKHSSS office bearers and Caretaker

39. The Executive Assembly may, if he deems appropriate-

- (a) extend the tenureship of the existing IRKHSSS office bearers to be a caretaker of the IRKHSSS until new office bearers is appointed; or
- (b) appoint any other students to be the caretaker of IRKHSSS until new officebearers is appointed.

PART X GENERAL

Validity of action in the absence of the candidate, etc.

40. No act done or decision made under this Regulations shall be questioned on the ground that such act or decision is done or made in the absence of the candidate, proposer and seconder of candidate's nomination if the said act or decision is done or made in good faith.

Amendment of regulation

41. The University or Kulliyyah authority may amend any provision of this Regulations.

Security supervision

42. The monitoring and overall supervision of the security of the AHAS KIRKHS election shall be the responsibility of the officer in charge of the security affairs of the University.

Disciplinary action

43. Any student who contravenes any provisions in this Regulations shall be liable to disciplinary action under the relevant disciplinary rules concerning students of the University.
